1. Government of Nepal has received financing from the World Bank toward the cost of Nepal Urban Governance and Infrastructure Project (NUGIP) and intends to apply part of the proceeds for consulting services for Design and Supervision Consultant (DSC).
2. The consulting services (“the Services”) of DSC is to provide support to Mechinagar Municipality in design and supervision of sub-projects. The estimated level of effort by DSC is 130 professional staff-months. The implementation period of DSC is approximately four years and the expected start date of its assignment is November 2021.

4. The Mechinagar Municipality now invites eligible Consulting Firms (“Consultants”) to indicate their interest in providing the Services. The shortlisting criteria are: *Core business and years in business, Relevant Experience, Technical and managerial capability of the firm.*
5. The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers” July 2016 Revised November 2020 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest.
6. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
7. A Consultant will be selected in accordance with the QCBS method set out in the Procurement Regulations. Further information can be obtained at the address below during office hours *i.e., 10:00 to 17:00 hours.*
